Course Overview

The course is designed to provide students with some of the essential conceptual and analytical tools for understanding Asian – Australian trade issues. The course serves as an introduction to Asia relations with Australia which will be of interest to a wide range of students, especially those whose future jobs might be related to Australia or to the Asia-Pacific region. The first part of the course examines selected thematic issues such as trade, foreign direct investment, foreign aid and globalization, while the latter part focuses on Australia's major bilateral and multilateral trade relationships in the Asian region. It is expected that on completing this course students will have acquired a basic understanding of the trade issues involved in Australia's relations with the Asia.

Learning Outcomes

At the successful completion of this course, students will be able to:

- Demonstrate some of the essential conceptual tools to analyse trade and trade issues between Asian region and Australia.
- Obtain the ability to understand key Economic, political, and strategic issues that confront Asia's trade relations with Australia.
- Demonstrate understanding of background and context to analyse Asia-Australia trade relations
- Demonstrate ability to write an academic essay incorporating a conceptual framework supported by empirical evidence.
